

SHORT TERM VACATION RENTAL (STVR) HOTLINE SUMMARY OCTOBER 31, 2019 TO DECEMBER 29, 2019


This Short-Term Vacation Rental Hotline Summary (Summary) covers the 9-week period of October 31, 2019 through December 29, 2019, which is when the City first brought Allied Security onboard. Allied Security is on duty Thursday, Friday and Saturday from 6:00 p.m. to 2:00 a.m., and Sunday from 10:00 a.m. to 8:00 p.m. No Hotline complaints were received during Weeks 1 and 5; and the full Hotline Report is attached.

During the reporting period there were a total of 34 Hotline Calls. Twenty-seven of the calls were on STVRs, two were on long-term rentals, and two were classified as Other. See Chart 1.

Most of the 34 Hotline calls received were related to noise complaints, followed by complaints of possible unpermitted STVRs.


From October 31 through December 29, 2019, 23 citations were issued for violations of the STVR ordinance; however, only two stemmed from Hotline complaints.


The next two charts show Hotline calls by date, time and type.

Chart 3 "Hotline Calls by Date and Time" shows that the majority of calls are from 9:30 p.m. to 12:00 a.m.

Because 24 of the 34 Hotline calls were Noise complaints, Chart 4 "Hotline Calls by Date, Time and Type" plots the dates, time and types of calls received, and breaks out the types of calls to show which were Noise complaints. While Chart 3 shows that the majority of calls were received in the late evening and early morning hours, Chart 4 further refines that information by showing that those same calls were Noise complaints.
