



SHORT TERM VACATION RENTAL SUMMARY AUGUST 2020 AUGUST 3, 2020 TO AUGUST 30, 2020

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for August 2020 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via GoRequest, email and/or direct call. The full Report is attached.

One hundred four (104) STVR complaints were received in August, of which ninety-seven (97) calls were received via the Hotline, and seven (7) were received via GoRequest. The graph below shows the number of calls received for each week of the reporting period.






Of the 104 calls received, 80 were on licensed STVR properties, 6 were on a Long-Term rental property, and 18 calls fell into neither category, and are classified as Unknown (UNK).

The Table above breaks down calls by week and type, while the pie chart depicts Calls by Complaint Type for the month.

Within the month there were several multiple or duplicate complaints on the same property.

The five (5) complaints classified as "Other" include calls to the Hotline from STVR owners contending possible false complaints/harassment, and calls relating to property maintenance and a miscellaneous inquiry.

For the month, seven (7) citations were issued because of the complaints received during the time period.
