



SHORT TERM VACATION RENTAL NOVEMBER 2020 NOVEMBER 1, 2020 TO NOVEMBER 30, 2020

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for November 2020 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via GoRequest, email and/or direct call.

On November 13, 2020, the STVR Compliance Team was available twenty-four hours a day, seven days a week to provide prompt response and resolution to all STVR complaints. The full Report is attached.

Sixty-three (63) STVR complaints were received in November, of which 48 calls were received via the Hotline, 4 via the Police Department, 1 via the Fire Department, and 10 were received via GoRequest. The graph below shows the number of calls received for each week of the reporting period.





Of the 63 calls received, 42 were on licensed STVR properties, 1 was on a Long-Term rental property, 1 was on a Commercial Business, and 19 calls fell into neither category, and are classified as Unknown (UNK).

The Table above breaks down calls by week and type, while the pie chart depicts Calls by Complaint Type for the month.

Within the month there were several multiple or duplicate complaints on the same property.

The four (4) complaints classified as "Other" include calls to the Hotline concerning civil issues, response protocol, COVID restrictions and a request for assistance from the Fire Department.

For the month, thirteen (13) citations were issued as a result of the complaints received during the time period.
