- Dispensaries are prohibited within 600 feet of a school, day care center, or youth center; or within 250 feet of East Palm Canyon Drive or a residential zone as defined by the City's Zoning Ordinance. Dispensaries are conditionally permitted in the I-1 Light Industrial, CBP-2 Commercial Business Park, and PCC Planned Community Commercial Districts. New dispensary licenses are not currently being issued for locations south of Interstate 10.
- Cultivation and Transportation/Distribution site facilities are prohibited within 600 feet of a school, day care center or youth center, or within 250 feet of East Palm Canyon or 300 feet of a residential zone as defined by the City's Zoning Ordinance and cultivation and transportation/distribution facilities are conditionally permitted in the I-1 Light Industrial, CBP-2 Commercial Business Park, and PCC Planned Community Commercial Districts.
- Manufacturing facilities are prohibited within 600 feet of a school, day care center or youth center, or within 250 feet of East Palm Canyon or 300 feet of a residential zone as defined by the City's Zoning Ordinance and are conditionally permitted in the I-1 Light Industrial District and the CBP-2 Commercial Business Parks.
- Testing Laboratories are permitted by right in PPO Planned Professional Office, PLC Planned Limited Commercial, and the NBP Neighborhood Business Park (Transition) Districts. They are also conditionally permitted in the PCC Planned Community Commercial, CBP-2 Commercial Business Park, and I-1 Light Industrial Districts.

INDEMNIFICATION AGREEMENT

Section 5.88.105 of the Cathedral City Municipal Code requires the applicant or its legal representative for a cannabis business license to execute an indemnification agreement. For the purposes of this indemnification agreement, the "Applicant" shall be the individual, firm, partnership, joint venture, association, corporation, limited liability company, estate, trust, business trust, receiver, syndicate, or any other group or combination acting as a unit, that is applying for the license and to whom the license will be issued if approved. The undersigned represents and warrants that he or she is duly authorized to sign this indemnification agreement on behalf of the Applicant and to bind the Applicant to the obligations contained herein.

Applicant shall, at Applicant's sole cost and expense, indemnify, protect, defend, and hold harmless, the City of Cathedral City, and/or any of its officials, officers, employees, agents, departments, agencies, and instrumentalities thereof (collectively, the "City"), from any and all claims, demands, law suits, writs of mandamus, and other actions and proceedings (whether legal, equitable, declaratory, administrative or adjudicatory in nature), and alternative dispute resolution procedures (including, but not limited to arbitrations, mediations, and other such procedures) (collectively, "Actions"), brought against the City related to the cannabis business license applied for herein. City shall promptly notify the Applicant of any Action brought and request the Applicant defend the City. City shall cooperate with Applicant in the defense of any Action. Applicant may select legal counsel providing the Applicant's defense and the City shall have the right to approve separate legal counsel providing the City's defense. The Applicant shall reimburse City for any attorneys' fees, costs and expenses directly and necessarily incurred by the City in the course of the defense. Applicant agrees that City will forward monthly invoices to Applicant for attorneys' fees, costs and expenses it has incurred related to its defense of any Action and Applicant agrees to timely payment within thirty (30) days of receipt of the invoice. City

may demand that Applicant submit a cash deposit or other security in an amount sufficient to cover the City's estimated attorney's fees, costs and expenses in the course of the defense of the Action in order to ensure timely payment of the City's invoices. The amount of security or cash deposit shall be determined by City. If Applicant does not submit the cash deposit or other security within twenty (20) days of demand by City, or Applicant does not timely pay any invoice submitted to Applicant, City may revoke the license or take any other action deemed necessary or advisable by City to protect itself against loss or damage.
