



SHORT TERM VACATION RENTAL MARCH 2021 APRIL 1 - 30, 2021

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for April 2021 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via GoRequest, email and/or direct call.

Sixty-five (65) STVR complaints were received in April, of which 38 calls were received through the Hotline, 15 were received through the Police Department, and 12 were received through GoRequest. The graph below shows the number of calls received for each week of the reporting period.






Of the 65 calls received, 41 were on licensed STVR properties, 0 were on a Long-Term rental property, 24 calls fell into neither category and are classified as Unknown (UNK).

The Table above breaks down calls by week and type, while the pie chart depicts Calls by Complaint Type for the month.

Within the month there were several multiple or duplicate complaints on the same property.

The four (4) complaints classified as "Other" include calls to the Hotline concerning a disturbance at a property, unsanitary condition of a pool, and a request to cancel a complaint.

For the reporting period, twelve (12) citations were issued as a result of the complaints received.
