B. **Century Park Renovation Project**

Recommendation: Authorize the City Manager to execute the documents required for the refurbishing of the existing Century Park playground equipment and replacement of the playground soft surface topcoat by Miracle Recreation Company, in the amount of \$116,834.35; and, purchase and install a USA Shade & Fabric Structures, Inc. shade structure to cover the playground in the amount of \$110,824.03; and Authorize the Director of Engineering/Public Works and Administrative Services Director to execute all required quotes and proposals for the labor and materials to complete the Project including tables, benches, and grills in the amount of \$25,034.79 and the replacement of the shade structures roofing systems in the amount of \$21,382.00, respectively. for a Project total of \$301,482.69, which includes a 10% contingency for unforeseen construction related expenses all to be funded from FY 2021-22 and 22-23 Parks Improvement and Maintenance Plan. Environmental Conservation Fund 246 and current FY Park Maintenance Budget 100-8301.

C. IT Assessment and Master Plan

Recommendation: Approve a Professional Services Agreement with Client First Technology Consulting to develop and provide a Comprehensive Information Technology (IT) Assessment and IT Master Plan in the amount of \$78,880 plus a 10% contingency of \$7,888 for a total budget amendment not to exceed \$86,768.
