



SHORT TERM VACATION RENTAL NOVEMBER 2021 NOVEMBER 1 – 30, 2021

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for November 2021 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via GoRequest, email and/or direct call.

Twenty-six (26) STVR complaints were received in November, of which 13 calls were received through the Hotline, 5 were received through the Police Department, and 8 were received through GoRequest. The graph below shows the number of calls received for each week of the reporting period.






Of the 26 calls received, 14 were on licensed STVR properties, 2 were on a Long-Term rental property, 10 calls fell into neither category and are classified as Unknown (UNK).

Of the 9 Possible Unpermitted STVR complaints, 1 was substantiated and a citation was subsequently issued.



The Table above breaks down calls by week and type, while the pie chart depicts Calls by Complaint Type for the month.

Within the month there were several multiple or duplicate complaints on the same property. 1 property received 4 complaints throughout the month.

The three (3) complaints classified as "Other" include eggs being thrown, a BB gun being fired, and a fire alarm. For the reporting period, three (3) citations were issued as a result of the complaints received.
