


# SHORT TERM VACATION RENTAL MONTHLY REPORT FEBRUARY 1 – 28, 2022

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for February 2022 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via MyCathedral, email and/or direct call.

26 complaints were received in February, of which 14 calls were received through the Hotline, 2 received through the Cathedral City Police Department, and 10 through MyCathedral. **10** of these calls were for permitted STVR properties, and the **8** were for suspected unpermitted STVR's. The remaining 8 calls were for non-STVR or STVR-related properties.


The remainder of this report will report on the 18 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 18 STVR-related calls:




