


## SHORT TERM VACATION RENTAL MONTHLY REPORT MARCH 1 – 31, 2022

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for March 2022 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, email and/or direct call.

21 complaints were received in March, of which 9 calls were received through the Hotline, 1 received through the Cathedral City Police Department, and 11 through the MyCathedral App. 4 of these calls were for permitted STVR properties, and 12 were for suspected unpermitted STVR's. The remaining 5 calls were for non-STVR or STVR-related properties.


The remainder of this report will report on the 16 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 16 STVR-related calls:




The Table below breaks down the 16 calls by week and type:


The Pie Chart to the right depicts the 16 calls by Complaint Type for the month of March:
