


SHORT TERM VACATION RENTAL MONTHLY REPORT APRIL 1 – 30, 2022

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for April 2022 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, email and/or direct call.

53 complaints were received in April, of which 39 calls were received through the Hotline, 6 received through the Cathedral City Police Department, and 8 through the MyCathedralCity App. 21 of these calls were for permitted STVR properties, and 12 were for suspected unpermitted STVR's. The remaining 20 calls were for non-STVR or STVR-related properties.


There was an increase in complaints from the previous months, primarily attributable to the music festivals. The remainder of this report will report on the 33 STVR-related calls only. 


The Pie Chart to the right depicts the 33 calls by Complaint Type for the month of April:
