


SHORT TERM VACATION RENTAL MONTHLY REPORT JULY 1 – 31, 2022

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for July 2022 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, email and/or direct call.

25 complaints were received in July, of which 23 calls were received through the Hotline, 1 received through the Cathedral City Police Department, and 1 through the MyCathedralCity App. 6 of these calls were for permitted STVR properties, and 4 were for suspected unpermitted STVR's. The remaining 15 calls were for non-STVR or STVR-related properties.


The remainder of this report will report on the 10 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 10 STVR-related calls:




The Table below breaks down the 10 calls by week and type:


The Pie Chart depicts the 10 calls by Complaint Type for the month of July:
