


## SHORT TERM VACATION RENTAL MONTHLY REPORT JANUARY 1 – 31, 2023

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for January 2023 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, email and/or direct call.

14 complaints were received in January, of which 8 calls were received through the Hotline and 6 through the MyCathedralCity App. None of these calls were for permitted STVR properties, and 11 were for suspected unpermitted STVR's. The remaining 3 calls were for non-STVR or STVR-related properties.


The remainder of this report will report on the 11 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 11 STVR-related calls:




The Table below breaks down the 11 calls by week and type:
