


SHORT TERM VACATION RENTAL MONTHLY REPORT MARCH 1 – 31, 2023

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for March 2023 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, email and/or direct call.

21 complaints were received in March, of which 14 calls were received through the Hotline, 2 through email, and 5 through the MyCathedralCity App. None of these calls were for permitted STVR properties, and 8 were for suspected unpermitted STVR's. The remaining 13 calls were for non-STVR or STVR-related properties.


The remainder of this report will report on the 8 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 8 STVR-related calls:




The Table below breaks down the 8 calls by week and type:
