


SHORT TERM VACATION RENTAL MONTHLY REPORT AUGUST 1 – 31, 2023

This Short-Term Vacation Rental Call Summary (Summary) covers the reporting period for August 2023 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, email and/or direct call.

10 complaints were received in August, of which 5 calls were received through the Hotline, 4 through the MyCathedralCity App, and 1 through email. None of these calls were for permitted STVR properties, and 6 were for suspected unpermitted STVR's. The remaining 4 calls were for non-STVR or STVR-related properties.


The remainder of this report will report on the 6 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 6 STVR-related calls:




The Table below breaks down the 6 calls by week and type:

While conducting my investigation the reporting party/ property manager told me the property was being rented via Airbnb. I was informed the renter had stayed at the location for 5 days (July 28th to August 2nd). Having previously worked on the STVR detail before, I am aware that STVR's are no longer allowed in the city with the exception of certain areas. Looking on Airbnb there appear to be several listings for the location as of current. The property has 11 units that I can recall from when I was there. From what I was told the Host(s) are a father and son, I was only able to obtain a name for the son. The son's name is XXXXXXX, and Airbnb shows the Host name as Will (I assume that is the father). I am unaware if the property has a permit or is allowed to run the location as a short-term rental.
