Recommendation: To award a construction contract to LCR Earthwork & Engineering Corp., in the amount of \$893,803.35 for the Cove Crack Repairs Project (C08675) and approve a twelve percent (12%) contingency in the amount of \$106,196.65 for any unforeseeable construction costs; thereby, bringing the total construction budget for this Project to \$1,000,000.00 to be funded with available Assessment District (AD) 2004-02 funds; and, authorize the City Manager to execute the required contract documents; and, authorize the City Engineer to request bonds and insurance for the Project and issue the Notice to Proceed.
