


SHORT TERM VACATION RENTAL MONTHLY REPORT JANUARY 1 – 31, 2024

This Short-Term Vacation Rental (STVR) Call Summary covers the reporting period for January 2024 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, email and/or direct call.

13 complaints were received in January, of which 11 calls were received through the Hotline and 2 through the MyCathedralCity App. None of these calls were for permitted STVR properties, but 2 were for suspected unpermitted STVRs. The remaining 11 calls regarded non-STVR or STVR-related properties.


The remainder of this report will report on the 2 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 2 STVR-related calls:
