


SHORT TERM VACATION RENTAL MONTHLY REPORT APRIL 1 – 30, 2024

This Short-Term Vacation Rental (STVR) Call Summary covers the reporting period for April 2024 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, email and/or direct call.

15 complaints were received in April, of which 9 calls were received through the Hotline, 5 through the MyCathedralCity App, and 1 through email. 2 calls were for permitted STVR properties and 6 were for suspected unpermitted STVRs. The remaining 7 calls regarded non-STVR or STVR-related properties.


The remainder of this report will report on the 8 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 8 STVR-related calls:




