


SHORT TERM VACATION RENTAL MONTHLY REPORT JUNE 1 – 30, 2024

This Short-Term Vacation Rental (STVR) Call Summary covers the reporting period for June 2024 and includes STVR calls/complaints to the STVR Hotline, Cathedral City Police Department, Cathedral City Fire Department, and those received via the MyCathedralCity App, Deckard, email and/or direct call.

12 complaints were received in June, of which 8 calls were received through the Hotline, 3 through the MyCathedralCity App, and 1 through the Deckard portal. 1 call was for a permitted STVR property and 5 were for suspected unpermitted STVRs. The remaining 6 calls regarded non-STVR or STVR-related properties.


The remainder of this report will report on the 6 STVR-related calls only. The graph below shows the number of calls received for each week of the reporting period for the 6 STVR-related calls:




The Table below breaks down the 6 calls by week and type:
