Monthly Summary

August 2025 demonstrated Cathedral City Fire & EMS's continued operational excellence with sustained high emergency response volumes and significant community engagement initiatives. The month was highlighted by the successful National Night Out event, comprehensive back-to-school safety programs, and the department's ongoing commitment to professional development and regional collaboration.

Throughout the month, the department responded to 697 emergency service calls, including 515 EMS incidents with 397 billable transports and 16 fire-related calls. With Medic 22 now fully integrated into operations, response capabilities remained strong across all service areas, while personnel continued advancing their skills through targeted training programs.

From meaningful community partnerships at National Night Out to proactive school safety initiatives and continued implementation of Measure W objectives, August showcased CCFE's dedication to serving Cathedral City with professionalism, compassion, and operational readiness.

Key Achievements

Mational Night Out Success

Participated in multiple neighborhood locations throughout the city, strengthening police-fire-community partnerships and fostering neighborhood connections on August 5th.

M Back-to-School Safety Initiative

Conducted comprehensive safety fair at Station 2 on August 16th, providing bike helmet fittings, pedestrian safety education, and school zone awareness to hundreds of families.

Fitness and Wellness Focus

Continued emphasis on firefighter health and wellness programs with enhanced physical fitness training and mental health support initiatives.

Operational Excellence

Maintained strong response metrics with 697 total calls while ensuring all apparatus remained in service with minimal downtime.

Regional Collaboration

Strengthened mutual aid partnerships through joint training exercises and coordinated responses to multi-agency incidents.

Professional Development

Advanced leadership training for company officers and specialized technical rescue certification programs.

Fire Prevention Success

Completed 135 fire inspections with high compliance rates, supporting community safety through proactive code enforcement.

Community Engagement

Multiple public education events reaching diverse populations with fire safety messaging and emergency preparedness training.



Mutual Aid & Major Incidents

Significant Fires

- **Structure Fires:** August saw several residential structure fires requiring aggressive interior attacks and coordinated ventilation operations. Quick response times and effective tactics minimized property damage and prevented fire spread to adjacent structures.
- Vehicle Fires: Multiple vehicle fires were successfully suppressed, including incidents on major roadways requiring traffic control and hazmat considerations for vehicle fluids.
- Outdoor Fires: Responded to several vegetation and refuse fires during high-temperature conditions, with crews working to prevent extension during extreme heat warnings.

Fire Prevention

Fire Prevention Activities

- 135 inspections passed out of 148 conducted in August
- Reviewed fire protection plans for:
 - Multiple commercial tenant improvements
 - Residential development projects
 - Updated fire alarm and sprinkler system installations
 - School facility safety upgrades before academic year
- Conducted pre-incident planning for high-risk occupancies
- Processed business licenses for new commercial ventures
- Completed annual inspections for educational facilities

Code Enforcement

- Conducted re-inspections of previously cited violations
- Addressed vegetation management concerns in wildland-urban interface areas
- Coordinated with schools for fire drill compliance
- Reviewed and approved emergency evacuation plans for large assembly occupancies

Community Risk Reduction & Community Engagement

Back-to-School Safety Programs

With the new academic year beginning, CCFE prioritized school safety through comprehensive programs including campus visits, evacuation drill supervision, and educator training on emergency procedures. These efforts ensure safe learning environments for Cathedral City students.

Heat Safety Campaign

During August's extreme temperatures, the department emphasized heat-related illness prevention through public messaging, cooling center information distribution, and increased readiness for heat emergencies.

Emergency Preparedness Education

Continued implementation of community emergency response training, helping residents prepare for disasters through hands-on education and resource distribution.

Fire Cadet Program

Cadets gained valuable experience through increased participation in department operations, community events, and specialized training modules preparing them for future careers in fire service.

Recruitment & Staffing

Personnel Updates

- Maintained full staffing across all shifts and stations
- Continued recruitment process for future academy class
- Advanced succession planning for anticipated retirements
- Implemented mentorship programs pairing senior members with newer personnel

Professional Development

- Company officers completed advanced incident command training
- Engineers received specialized apparatus operator certification
- Paramedics completed continuing education requirements
- All personnel maintained required certifications and training hours

- School Zone Safety: Reduced speeds, crosswalk awareness, bus stop safety
- Home Fire Prevention: Test smoke alarms for back-toschool season, review family escape plans
- Pool Safety: Maintain supervision as pool season continues, secure pool areas

- Review family communication plans
- Ensure emergency kits are stocked and current
- Register for CodeRED emergency notifications
- Know evacuation routes and shelter locations
