**I. RECOMMENDATION:**

Adopt Proposed Resolution reciting the fact of the General Municipal Election held on November 2, 2010, declaring the result thereof and other such matters as provided by law.

**II. BACKGROUND:**

State Law provides that canvass of the election results shall be completed and the results certified by no later than the fourth Tuesday following the General Municipal Election, when it is consolidated with the Statewide General Election.

The Riverside County Registrar of Voters has completed their canvass of the election and the results are included as Exhibit "A" to the attached Resolution. In Accordance with State Law, the City Council must, by no later than December 8, 2010, adopt the Proposed Resolution with meets all of the requirements of State Law for certifying and declaring the results of the November 2nd General Municipal Election.

The Proposed Resolution declares that as a result of the General Municipal Election held November 2, 2010, (1) Kathleen J. DeRosa was duly elected as Mayor; (2) that Sam Toles was duly elected as a member of the City Council, and that Charles "Chuck" Vasquez was duly elected as a member of the City Council (3) Henry H.C. Chan was duly elected as Treasurer and (4) Pat Hammers was duly elected as City Clerk.

The Installation of the newly elected Officials (Oaths) will take place immediately following the Presentations to City Council.

## **RESOLUTION NO. 2010-109**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CATHEDRAL CITY, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN SAID CITY ON NOVEMBER 2, 2010, DECLARING THE RESULT THEREOF AND OTHER SUCH MATTERS AS PROVIDED BY LAW.**

**WHEREAS**, a regular General Municipal Election was held and conducted in the City of Cathedral City, California, on Tuesday, November 2, 2010; and

**WHEREAS**, notice of said election was duly and regularly given in time, form, and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects said election was held and conducted and made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in cities; and

**WHEREAS**, pursuant to Resolution No. 2010-81 adopted June 09, 2010, the Registrar of Voters of Riverside County canvassed the returns of said election and has certified the results to the City Clerk and the City Clerk completed the canvas and has certified the results to this City Council, said results are received, attached and make a part hereto as "Exhibit A."

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CATHEDRAL CITY, CALIFORNIA, DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

**SECTION 1.** There are 16 voting precincts established for the purpose of holding said election consisting of consolidations of the regular election precincts in said City as established for the holding of State and County elections.

One (1) Mayor of said City for the City for the full-term of two years

Two (2) members of the City Council of said City for the full-term of four years.

One (1) City Treasurer of the said City for the full-term of four years.

One (1) City Clerk of the said City for the full-term of four years.



**SECTION 2.** That the whole number of votes cast in said City (except Vote by Mail ballots) was **XXXXXX**

**SECTION 3.** That the whole number of Vote by Mail ballots cast in said City was **XXXXXX** making a total of **XXXXX** votes cast in said City.

**SECTION 4.** That the names of persons voted for at said election for Mayor of said City are as follows:

That the names of persons voted for at said election for City Clerk are as follows:

That the number of voters given at each precinct and the number of votes given in the City to each of such persons above named for office for which said persons were candidates were as listed in Exhibit "A" attached.

**SECTION 5.** The City Council does declare and determine the following: Voters; the voters have elected **Kathleen J. DeRosa as Mayor** of said City for the full term of two years; **Sam Toles and Charles "Chuck" Vasquez** were elected as members of the City Council for the full term of four years; that **Henry K.C. Chan** was elected as Treasurer for a full term of four years; and that **Pat Hammers** was elected as City Clerk for a full term of four years.

**SECTION 6.** The City Clerk shall enter on the records of the City Council of said City, a statement of the result of said election, showing:

- (1) The whole number of votes cast in the City;
- (2) The names of the persons voted for;
- (3) For what office each person was voted for;
- (4) The number of votes given at each precinct to each person; and
- (5) The number of votes given in the City to each person.

**SECTION 7.** That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated, that the City Clerk shall have administered to each person elected the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe thereto and file the same in the office of the City Clerk. Whereupon, each and all of said persons so elected shall be inducted into the respective office to which they have been elected.

**SECTION 8.** That the City Clerk shall certify to the passage and adoption of this Resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute of passage and adoption thereof in the records of the proceedings of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.
